Purchase Awards have varied interpretations; to avoid confusion, we want to address this aspect of the show. Regardless of the price of your work, the designated amount will be awarded if your piece is chosen by the donor. A 35% commission will not be charged by the Anderson Arts Center for Purchase Awards. Therefore, it is not necessary to raise or lower the price of a piece of work if you wish to be considered. Several sales opportunities will be offered, so please consider this when pricing your piece. Mark the appropriate box on the entry card if your piece is available for a Purchase Award.

Sale of Your Work

All entries are available for sale through the gallery, unless otherwise noted. A 35% commission will be charged by the Anderson Arts Center. If a work is not for sale, NFS must be noted on your entry card. No PORs (price on request) will be accepted. Works for sale must have price listed and will be sold as exhibited. A preview of all submitted works will be available to area designers and collectors.

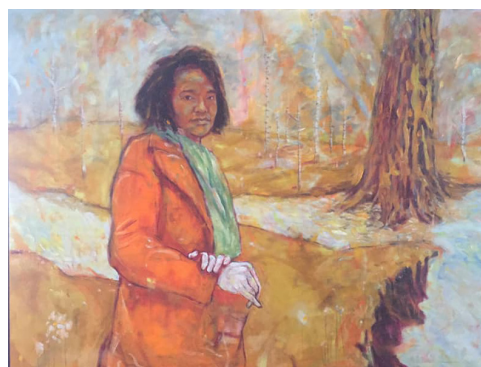

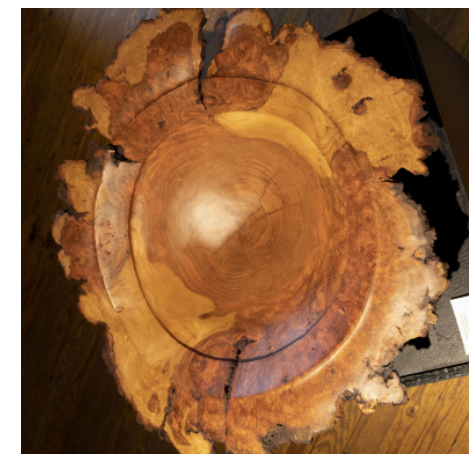
OUR JUROR: JOSEPH PERAGINE

ELIGIBILITY

All artists 18 years or older may submit works for this show. Only original works of art not shown previously at the Anderson Arts Center and created within the last two years are eligible. These works may be in any media including painting, pastel, drawing, sculpture, pottery, photography, fibers, print making, weaving, basketry, graphics, wood, etc. All works to be hung must be professionally framed and **securely wired** and, if subject to damage, must be framed under Plexiglas or glass; gallery wrapped canvas is acceptable. **No clip mounting will be accepted.** Three-dimensional work must sit solidly on a flat surface or be properly mounted for hanging. **If works are not adequately prepared for display, they will be withdrawn from jurying.** While there are no size restrictions, entries must be transportable and able to be hung in a conventionally sized gallery.

ENTRY FEE

A non-refundable fee of \$35 per artist for one or two entries is to be submitted upon delivery of work to the Anderson Arts Center, or upon Shuttle Service Pickup (additional \$10 fee for Shuttle Service; \$45 total). Artist may enter more than once (additional \$35 for two additional pieces).

Join us for a unique event that not only includes the Arts Center but also Downtown Anderson businesses for the Ninth Annual "Art on the Town." This is another fabulous opportunity to exhibit and sell your work. Any works remaining after the jurying process will be eligible to be included in Art on the Town.

Artwork will be on view starting **Saturday, May 9. This includes a gallery crawl, artist demonstrations, artists booths and an after-party at Wren Park, Saturday, May 9.**

LIABILITY

The Anderson Arts Center assumes responsibility for insuring and caring for the works of art selected for exhibition while they are in our possession. However, the Anderson Arts Center will not assume costs of shipping artwork or insurance while in transit to or from the Anderson Arts Center. The Anderson Arts Center reserves the right to refuse any entry and to withdraw any work from the exhibition at its discretion. The Anderson Arts Center reserves the right to photograph and reproduce any entry submitted for educational or publicity purposes. The receipt of an entry in the juried exhibition will constitute agreement by the artist with all conditions set forth in this prospectus.

NOTIFICATION

Notification of juried results will be mailed by March 27, 2020. Please be sure to SELF ADDRESS AND STAMP the attached Juror's Result Card. Results will also be posted on our website by March 27, 2020. **No notifications will be given over the phone.**

PARTNERSHIP for PUBLIC ART.

SculpTOUR

Sculpture artists are also invited to participate in our Juried Show through the Anderson Arts Center/City of Anderson's Partnership for Public Art: SculpTOUR. This competition and exhibition allows for up to six outdoor sculptures to be juried into a year-long outdoor exhibition with cash prizes of \$1,000 each. A special sculpture selection committee will juror this artwork.

Selected pieces will be installed by May 9, the Art on the Town event, and must remain for one year. This event is considered the opening reception of the year-long exhibit.

Artists chosen as finalists will be required to be available during the installation and take down processes. All installation costs and insurance will be the responsibility of the Anderson Arts Center.

To enter, you will complete the juried show entry card, pay the appropriate fee (\$35 for two entries), and submit your work during the take-in for the juried show (March 19-21). If your pieces are too large to be submitted at take-in, you must still complete the juried show entry cards, pay the fee and email complete descriptions and photos of the work, as well as an artist resume to info@andersonarts.org by March 19. ART SHUTTLE SERVICE

There will be an Artwork Shuttle Service to select areas in South Carolina. Artists will have the opportunity to deliver Juried Show entries to a central location in each of these cities. **There will be an additional \$10 fee for this service.**

The Anderson Arts Center will pick up the entries, and then return the work after the show closes in June. All works participating in the process will be covered by liability insurance. All work **MUST** be boxed in a **reusable** container, with each box labeled with the artist's name, name of the piece, email address, phone number and address. **All entries requiring shuttle service must register and notify the Arts Center by email before March 13.** Work inappropriately boxed will **NOT BE ACCEPTED.**

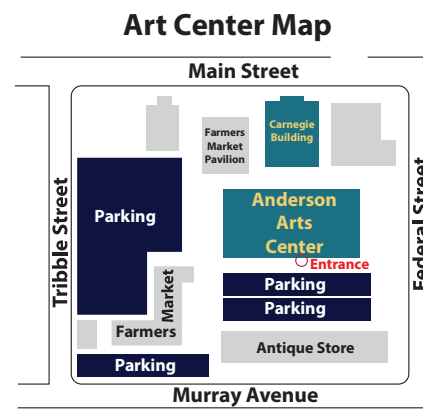

ACCEPTED ENTRIES may be picked up at the Arts Warehouse on Thursday, June 4, 10am - 5:30pm, Friday, June 5, 10am - 5:30pm, and Saturday, June 6, 10am - 4pm.

After July 30, 2020, all work not picked up becomes the property of the Anderson Arts Center.

DIRECTIONS TO THE ARTS WAREHOUSE

From Greenville, SC

Take I-85 South to Exit #27 at Highway 81. Turn left, and cross over the interstate; proceed toward Anderson. Highway 81 becomes Greenville Street. When you reach Main Street, turn left, go 3 blocks and turn right onto Federal Street. The Warehouse is located at 110 Federal Street.

From Columbia, SC

Take I-26 from Columbia. Exit I-385 toward Greenville/Laurens. In Greenville take I-85 South to Exit #27. Turn left, cross over the interstate and continue toward Anderson. Continue on Highway 81 (which becomes Greenville Street) into town until you reach Main Street. Turn left onto Main, go 3 blocks and turn right onto Federal Street. The Warehouse is located at 110 Federal Street.

From Atlanta, GA

Take I-85 to the Anderson/Clemson exit #19A. Turn right toward Anderson; you are on Clemson Boulevard. Clemson Boulevard becomes Main Street. When you cross Greenville Street, continue 3 blocks. Turn right onto Federal Street. The Warehouse is located at 110 Federal Street.
